Award of Works for Improvement and Widening of Chitral-Booni-Mastuj-Shundur Road: Package-II: Pret-Booni (KM 38+965 to KM 78+688)

Decision

The NHA Executive Board approved the award of works for improvement and widening of Chitral – Booni – Mastuj - Shundur Road; Package-II: Pret - Booni (KM 38+965 to KM 78+688) to the lowest evaluated bidder M/s Umer Jan & Company at their evaluated bid price of Rs.2,829,340,008/- (Rupees two billion, eight hundred twenty nine million, three hundred forty thousand and eight only) which is 31.58% below the Engineer's Estimate of Rs.4,135,406,380/based on CSR-2014 with the condition that amount of Performance Security shall be increased to two (02) times as per clause IB 28.4 of Bidding Document.

TORs of the committee are given below:

- a. To incorporate clause in "Instruction to Bidders" that in case of winning one or two packages of the same project advertised under one IFB, the bidder will not be entitled for award in remaining packages.
- b. To analyze & study the factors that lead to very low bids comparing Engineer's Estimates.
- c. Possibility of provision of bid security and performance security in the form of bank guarantee instead of insurance guarantee.
- d. Any other TOR considered appropriate/relevant by the committee.

The above committee shall submit its recommendations to the Board before next meeting.

Award of Works for Improvement and Widening of Chitral-Booni-Mastuj-Shundur Road: Package-III: Booni - Shaidas (KM 78+688 to KM 114+833)

Decision

The NHA Executive Board approved the award of works for improvement and widening of Chitral – Booni – Mastuj - Shundur Road: Package-III: Booni - Shaidas (KM 78+688 to KM 114+833) be awarded to the lowest evaluated bidder M/s Umer Jan & Company at their evaluated bid price of Rs.2,546,315,595/- (Rupees two billion, five hundred forty six million, three hundred fifteen thousand, five hundred and ninety five only), which is 33.14% below the Engineer's Estimate of Rs.3,808,670,432/- based on CSR-2014 with the condition that amount of Performance Security shall be increased to two (02) times as per Clause IB 28.4 of Bidding Document.
