### Agenda Item 2

Consultancy Services for Construction Supervision for Maintenance Works of NHA for the Years 2018-19, 2019-20 and 2020-21

### **Decision**

The NHA Executive Board approved the award of consultancy services for "Construction Supervision for Maintenance Works of NHA for the years 2018-19, 2019-20 and 2020-21" to M/s PEAS Consulting (Pvt.) Ltd. in JV with M/s Indus Associated Consultants (Pvt.) Ltd., M/s Cameos Consultants and M/s Hussain Engineering Services, the successful Consultants in the Combined (Technical + Financial) evaluation at evaluated cost of Rs.698,329,904/-, (which includes Salary Cost, Direct Non-Salary Cost and all type of applicable taxes) and Rs.111,732,785/-as sales tax @ 16%. Hence, total contract value become Rs.810,062,689/- (Rupees eight hundred ten million, sixty-two thousand, six hundred & eighty-nine only).

The NHA Executive Board approved the award of consultancy services for "Road Condition Survey and HDM Analysis for Preparation of AMP 2021-22, 2022-23 & 2023-24" to M/s Partners in Development-PID in JV with M/s Associated Consultancy Centre (Pvt.) Ltd., M/s Creative Engineering Consultants and M/s Global Consultants, the successful Consultants in the (Technical+Financial) evaluation at evaluated cost of Rs.76,964,320/-(i.e. Salary Cost, Non-Salary Cost and all other applicable taxes except GST) and Rs.12,314,291/- (as General Sales Tax @ 16%). Hence, grand total of the Contract value is Rs.89,278,611/- (Rupees eightynine million, two hundred seventy-eight thousand, six hundred & eleven only).
