Agenda Item 1

Confirmation of Minutes: 357th Meeting of NHA Executive Board held on May 24, 2021

Decision

The NHA Executive Board confirmed minutes of the 357th Executive Board meeting held on May 24, 2021, however, deferred Agenda Item No. 02 regarding "Award of Works: Improvement and Widening of Chitral-Booni-Mastuj-Shundur Road Package-IV: Shaidas - Shundur (Km 114+833 to Km 152+615)" with the direction to verify the credit line facility submitted by the lowest evaluated bidder and present the agenda again for consideration by the Board.

Agenda Item 2

PC-I for Construction of Kharian - Rawalpindi Motorway on PPP Basis

Decision

The NHA Executive Board recommended the PC-I for construction of Kharrian - Rawalpindi 4-lane Motorway having 6-lane structures (117.1 Km) at the cost of Rs.88.32 billion for consideration of CDWP.

The Board directed that:

- a. Local and international bidders be invited through Request for Proposal (RFP) for construction projects for motorways on PPP/BOT basis.
- b. A clause be incorporated in "Instructions to Bidder" that prospective bidder must have experience of successful execution of PPP projects at national/international level.

Agenda Item 3

Award of Works for Rehabilitation and Upgradation of Jhaljao – Bela Road (Km 54+800 to Km 134+690) 79.89 Km

Decision

The NHA Executive Board approved the award of works for "Rehabilitation and Upgradation of Jhaljao – Bela Road (KM 54+800 to KM 134+690) 79.89 KM" to the lowest evaluated bidder M/s JHCEC-ABD (JV) (JV of M/s Jiangsu Haitong Construction Engineering Co. Builders Ltd. M/s Aitmaad & Developers) evaluated/corrected bid price of Rs.7,498,063,546/- with voluntarily rebate of 3.865754% having continuous effect, thereby final bid price of Rs.7,208,206,845/- (Rupees seven billion, two hundred eight million, two hundred six thousand, eight hundred and forty-five only), which is 24.61% below the Engineer's Estimate of Rs.9,560,854,846/based on CSR-2014 with the condition that the amount of Performance Security shall be increased to two (02) times as per Clause IB 28.4 of Bidding Document.

Agenda Item 4

Award of Consultancy Services for Design Review and Construction Supervision for Dualization of Quetta Western Bypass (22.7 Km)

Decision

The NHA Executive Board approved the award of agreement for Consultancy Services for "Design Review and Construction Supervision for Dualization of Quetta Western Bypass (22.7 km)" to M/s PEAS Consulting (Pvt.) Ltd in JV with M/s Engineering Consultancy Services Punjab and M/s AAN Consulting Engineers, the successful Consultants in the Combined (Technical + Financial) evaluation at the evaluated cost of Rs.47,993,171/- (which includes salary cost, direct non salary cost and all type of applicable taxes except GST) and Rs.7,678,907/- (as General Sales Tax @ 16%). Hence, total contract value becomes Rs.55,672,078/- (Rupees fifty-five million, six hundred seventy-two thousand, and seventy-eight only).

Lot#1: Behrain-Kalam (8 Bridges) KM 106+025 to KM 122+626 Lot#2: Behrain-Kalam (4 Bridges) KM 127+157 to KM 132+675

Decision

The NHA Executive Board approved the award of Works, Package-2A: Rehabilitation of National Bridges Behrain-Kalam (N-95) KM 106+025 to KM 132+675 (12 Bridges) Lot-1: Behrain-Kalam (8 Bridges) Km 106+025 to Km 122+626) and Lot-2: Behrain-Kalam (4 Bridges) Km 127+157 to Km 132+675) to M/s Sachal Engineering Works (Pvt.) Ltd. at their quoted/ evaluated bid price of Rs.504,869,440/- (Rupees five hundred four million, eight hundred sixty-nine thousand, four hundred & forty only) for Lot-1 and Rs.348,032,580/- (Rupees three hundred forty-eight million, thirty-two thousand, five hundred & eighty only) for Lot-2, which is 19.10% and 25.95% above Engineer's Estimate based on CSR-2014 respectively.
