

Agenda Item 2

Overlay and Modernization of Lahore – Islamabad Motorway (M-2) on Build-Operate-Transfer (BOT) Basis: Operation and Maintenance of Neela Dullah Interchange (M-2) – Mangwal Road (21.6 km) as Extension of M-2 (Strategic Link) by Motorway Operations and Rehabilitation Engineering (Private) Limited (M/s More) Through Variation Order

Decision

The NHA Executive Board approved the following:

- a. The Strategic link road, Neela Dullah Interchange (M-2)–Mangwal Road as extension of M-2 be made part of Lahore-Islamabad Motorway with total project length of 378.60 KM for maintenance, operation & management purposes through variation order under Clause 29.1 of Concession Agreement.
- b. Operation management and routine maintenance cost amounting to Rs.284.73 Million (for 13 Years) and periodic maintenance shall be carried out when qualifies as per road condition and cost shall be calculated on the prevailing CSR has mutually agreed between both NHA and M/s FWO (MORE).

Revised PC-I for Construction of Lahore Sialkot Motorway Project (LSMP).

Decision

The NHA Executive Board directed NHA to evaluate the PC-I for construction of Lahore Sialkot Motorway Project and if scope of the work is increased, revised PC-I for (+) 3.296% may be prepared and submitted for approval as per competency and guidelines issued by the Planning Commission.

The NHA Executive Board approved the Addendum/VO-3 of M/s PEAS Consulting (Pvt) Ltd. for Construction Supervision for Conversion of 2-Lane Lai & Swan Bridges to 4-Lane Bridges at Km 1533-1534 (N-5) amounting to Rs.43,116,444/- (Rupees forty-three million one hundred sixteen thousand four hundred forty-four only) yielding with revised Contract cost of Rs.69,902,021/- and overall increase of 160.97% up to April 30, 2022.
