# <u>Agenda Item 2</u> Revised PC-I for the Construction of Sialkot (Sambrial) - Kharian Motorway on PPP Mode.

### **Decision**

The NHA Executive Board recommended the revised PC-I for the approval of CDWP/ECNEC for "Construction of 4-lane Sialkot (Sambrial) – Kharian Motorway" at the Revised PC-I Cost of Rs.32,102,900,351/- (Rupees thirty-two billion, one hundred two million, nine hundred thousand, three hundred fifty-one only) including Upfront Viability Gap Funding (VGF) of Rs.4,000 Million and Operational VGF of Rs.6,944 Million for first eight operational years in equal annual installments.

Consultancy Services for Feasibility Study and Detailed Design for Realignment of KKH from Thakot to Raikot due to Construction of Dams on River Indus.

## **Decision**

The NHA Executive Board approved award of Contract for Consultancy Services for "Feasibility Study and Detailed Design for Realignment of KKH from Thakot to Raikot due to Construction of Dams on River Indus" to M/s NESPAK (Pvt.) Ltd. in JV with M/s Euroconsult Pakistan (Pvt.) Ltd. and M/s Harza Consultants (Pvt.) Ltd., the successful Consultants in the Combined (Technical + Financial) evaluation at evaluated cost of Rs.228,747,939/- (Rupees two hundred twenty eight million, seven hundred forty-seven thousand, nine hundred and thirty-nine only), which includes all types of Federal, Provincial and Local Taxes including General Sales Tax (GST).

The above decision is subject to clearance by DDWP with respect to variance in bid cost vis-à-vis allocation.
