Sub: UPDATION OF DEPENDENTS IN HRMIS & MEMIS

In order to facilitate all NHA employees for medical & pension purposes, verification of dependents of NHA's employees was started w.e.f July 01, 2021, to update HRMIS & further integration with MEMIS.

2. Although, majority of employees have provided required information/ documents, however, despite repeated instructions a large number of personnel are either reluctant to submit such information or they have submitted incomplete information which cause inconvenience to complete the assignment. This tendency drastically affected completion of data base.

3. The Competent Authority has taken serious view of this non-compliance and decided to suspend medical facilities including payment of monthly medical allowance in respect of the officers/officials failed to provide the requisite information. The facility shall only be restored upon receipt of requisite data and its verification by concerned Admn Office.

4. Director (Establishment) NHA, HQ and all regional In-charges of Administration are requested to implement the orders forthwith and stop their medical facilities as no further relaxation shall be granted. Similarly, Accounts Sections concerned are also requested to stop payment of monthly medical allowance to the defaulter(s) **(List is Enclosed)**.
