# Conversion on Real Time M-Tag Based Tolling from Manual Toll Collection on Motorways in the Best Interest of Public

- 7.1. The Executive Board was requested to deliberate on the proposal on the following grounds in the light of PPRA Rule 42 (f) and NHA Tolling Policy:
  - a. Switching from net guaranteed manual tolling to percentage sharing basis through M-tag on all Motorways (Ref. NHA Tolling Policy Clause 23).
  - b. The total contract period shall be up to five (05) years. Initial term of Contract to be One (01) year extendible on yearly basis based on satisfactory performance (complete visibility and disbursement of Revenues to NHA Account) and its approval by NHA Executive Board. During the aforementioned period FWO will provide the following:
    - i. Transformation from Manual to Electronic toll collection.
    - ii. Hardware required for M-Tag (including AVC for audit purpose).
    - iii. Software for M-Tag and tolling etc.
    - iv. Provide installation and recharge facility of M-Tag to commuters.
    - v. Technical support for installed system/ equipment along with supply of spares, as and when required after DLP.
    - vi. OM&M of toll plazas (M-1, M-3, M-4, M-5, M-14 & E-35).
  - c. The above approval shall be subject to a written guarantee from Engineer in Chief on the following:



- i. All data of Motorways will be shared with NHA on real time basis (24x7) 365 days with primary server will be set up at Operations Center at NHA, HQs.
- ii. All M-Tag revenue shall be parked into NHA Road Maintenance Account and NHA will pay share on agreed percentage of invoices.
- iii. Auditable system having Automatic Vehicle Classification (AVC) should be installed to allow verification and authentication of revenue.
- d. The NHA shall also engage separate/independent services to review and verify the data on shift and daily basis. This will help in getting maximum visibility of revenue and to resolve conflicts that may arise while processing of a huge quantum of transactions arising through electronic toll collection.
- e. It is appraised that there is no rate analysis committee is defined in NHA Code 2005, therefore, following committee is proposed for rate analysis for price reasonability:

### **Decision**

The NHA Executive Board approved, in principle, conversion of manual toll collection to real time M-Tag based tolling on Motorways as per Para-7.1 above and initiation of case for engaging separate/independent services as mentioned in Para 7.1(d) along with the following:

- a. Acceptance, in principle, for Conversion on M-Tag Based Tolling from Manual Toll Collection on Motorways.
- b. Acceptance of necessity as the same is in best public interest to reduce queuing at exit points of motorways.
- c. Administrative approval to proceed as per PPRA Rule 42 (f) Direct Contracting with State Owned Entities.
- d. The total contract period shall be up to five (05) years. Initial term of Contract to be One (01) year extendible for year to year basis based on satisfactory performance (complete visibility and disbursement of Revenues to NHA Account) and its approval by NHA Executive Board.
- e. Upon expiry/termination of contract period the ownership of all M-Tag (hardware & software and database) shall be transferred to NHA.
- f. Upon expiry/ termination of contract period, NHA may auction Toll Collection rights through open competitive bidding.
- g. The top up/ recharge of M-Tag revenue will be directly deposited to NHA designated bank account.

The Board formulated a committee comprising of IG (NH&MP), Chief (NTRC) and Member (Finance), NHA to oversee the proposal in accordance with the observations of the Board.



The Board directed that comprehensive e-tolling working/mechanism so formulated shall be presented before the Executive Board for approval.

Addendum No. 01 of M/s NESPAK-TURKPAK (JV) for Design Review & Construction Supervision of Dualization & Improvement of Pindigheb - Kohat Road (Length#80 Km)

The NHA Executive Board approved the Addendum No. 01 of M/s NESPAK-TURKPAK (JV) for Design Review & Construction Supervision of Dualization & Improvement of Pindigheb - Kohat Road (Length: 80 Km) amounting to Rs.36,784,354/- (Rupees thirty-six million, seven hundred eighty-four thousand, three hundred & fifty-four only) with revised consultancy contract cost of Rs.162,603,406/- with an overall increase of 29.24% from original cost and EOT of 14 months from August 01, 2020 to September 31, 2021 for Construction Period and 03 months of skeleton staff to be spread up to December 31, 2022 covering Defect Liability Period and finalization of Accounts in all respects.

## Agenda Item 6

Report of Committee Constituted by Executive Board in its 371st Meeting Held on October 15, 2021 to Review the Existing Ratio of 20% Share of Small Consultancy Firms in Main Consultancy Agreements.

### **Decision**

The NHA Executive Board reconsidered its earlier decision made in its 274<sup>th</sup> meeting held on February 14, 2017 on agenda item 12 regarding "Improvements in the Procurement Process & Evaluation Criteria for Consultancy Services" and approved the following recommendations of the committee:





- a. The nomenclature of new/less experience firm be nominated as sub-consultant, whose name will be stated in the proposed bid document.
- b. The percentage of assignment vis-à-vis input be limited to 7.5%.
- c. The new firm must be registered with Pakistan Engineer Council (PEC) but the requirement of the specific PEC profile code is mandatory for the input he is likely to render.
- d. The new company shall not be jointly or severally responsible for the performance of the contract.
- e. The new company after having executed three relevant projects be promoted to an independent regular firm. The new company will not be overburden with more than two projects simultaneously having overlapping effect.
- f. 50 additional marks shall be awarded for associating new firm as sub-consultant in the proposed bid.
