Approval for Award of Periodic Maintenance Work (Structural Overlay) Between KM:33+500 to KM:43+000, KM:53+000 to KM:56+000 & KM:60+000 to KM:70+300 on N-35 (Haripur-Havaelian-Abbottabad) Under AMP 2019-20.

Decision

The NHA Executive Board approved the award of Rehabilitation Works viz PM-2019-20-NA-02 for Northern Area Region under AMP-2019-20 to the lowest bidder M/s Mehboobi Associates at evaluated bid price of Rs.307,549,526/- (Rupees three hundred seven million, five hundred forty-nine thousand, five hundred & twenty-six only), which is 36.81% below the Engineer's Estimate of Rs.486,706,007.94.

The Board further directed that the lowest evaluated bidder shall provide/furnish 10% additional Performance Security in addition to Performance Security (10%) stipulated in "Appendix-A to Bid" as per Clause IB-28.4.

Decision

The NHA Executive Board directed as follows:

Dualization Rehabilitation of Karachi-Quetta-Chaman on BOT Basis Under PPP Arrangement or Through PSDP.

Decision

Construction of Peshawar Northern Bypass Road, Package-II, "Amendment to the Contract and Change of Source of Steel for Basic Rates for Price Adjustment, Appendix-C".

Decision

The NHA Executive Board approved the following:

- a. Replacement of source of steel for price adjustment as Monthly Statistical Bulletin Pakistan Bureau of Statistics (Peshawar) instead of Pakistan Steel Mills and subsequent amendment to the contract.
- b. Base Rates prevailing on July 01, 2013 (which is 28 days prior to the latest date of submission of Bid/Opening dated of July 29, 2013) for use in the price adjustment formula under Clause 70.1 as per the following detail:

Addendum No. 01 of M/s Zeeruk International (Pvt) Ltd: Construction Supervision of 06-Lane Highway from Kala Shah Kaku to Lahore Ring Road {Lahore Eastern Bypass Project (LEBP)}

Decision

The NHA Executive Board approved the Addendum No. 01 of Rs.14,054,425/- (Rupees fourteen million, fifty-four thousand, four hundred & twenty-five only) with revised consultancy services cost of Rs.45,621,857/-, which is 44.52% above the original cost, entailing extension of time from November 10, 2019 to June 30, 2022 and it also includes three (03) months for the RE & QS each for (Scattered up to June 30, 2022) supervision of remaining works during DLP and project finalization after the DLP.
