Policy Decision, Regarding Inclusion of Price Adjustment Clause in the ongoing Periodic Maintenance Works through Amendment in Contracts as per PEC Guidelines June-2022

Decision

The NHA Executive Board recommended the policy decision for approval of National Highway Council (NHC), regarding inclusion of Price Adjustment Clause in ongoing Periodic Maintenance Works through an amendment into the contracts as per revised PEC Standard Procedure for Price Adjustment issued in June 2022 with following conditions:

- a. The Price Adjustment shall be applicable on all the contracts, commenced after the cutoff date i.e. July 01, 2021.
- b. Works with original completion date before the cutoff date (w.e.f. July 01, 2021) shall not be considered for Price Adjustment.
- c. The quantum of balance work for contracts with original completion date after the cutoff date (July 01, 2021) shall be determined from the original work schedule. The current rate for calculation of price adjustment shall be determined 28 days prior to the original scheduled date of completion.
- d. Extension of Time shall be granted for the completion of works but the Price Adjustment shall be applicable as payable in full for the original scheduled completion period. The rate of Price Adjustment will be frozen at the original scheduled date of completion.
