CIRCULAR

Subject: **JAPANESE GOVERNMENT MEXT SCHOLARSHIP UNDER YOUNG LEADERS PROGRAM (YLP) FOR YEAR 2023 AT SCHOOL OF LOCAL GOVERNANCE AND SCHOOL OF GOVERNMENT.**

The Ministry of Communications, Islamabad has forwarded a copy of Economic Affairs Division OM No. 1(53) Japan-II/2022 dated August 31, 2022 announcing the Japanese Government MEXT Scholarship for 2023 in the field of "School of Local Governance" and School of Government" scheduled to be held from October 2023 to October, 2024 (One Year) in Japan.

Eligibility Criteria of (Sponsors)

a.	Be a young public administrators and government officials who are expected to play active roles in future as national leaders.
b.	Have at least 3 years of full time work experience in total as of October 01, 2023 in public administration (preferably 5 years or more)
c.	Be under 40 Years age as of October 01, 2023.
d.	Have Bachelor's degree holder or equivalent from a recognized/accredited University or college with excellent academic performance.
e.	Be proficient in Spoken and written English (with a TOEFL-iBT score of 79, IELTS Academic score of 6.0 or equivalent)
f.	Be in good health, both physically and mentally to participate in the program.
g.	Not be a Military personnel or military-civilian employees.

NHA's Eligibility Criteria

a.	Minimum three years' service in NHA.
b.	Must be a regular employee of NHA.
c.	The employee has not attended any other program abroad for duration of more than one month during last one year.
d.	His / her job is related to the scheduled program
e.	Not dealing with any special assignment
f.	Neat and clean service record & no departmental proceedings are pending or under process against him or area of his existing responsibility
g.	The employee is not on long leave (leave of 30 days or more)
h.	He is not dealing with a special assignment
i.	He is not under medical treatment/leave for long time
j.	Recommendation by the Member In-charge

Matter is circulated for information, dissemination and seeking suitable nominations/willingness of Officers **who fulfill the above mentioned criteria of Sponsors/NHA** in said scholarship programs which are **relevant** to the functions of the authority along with 05 sets of duly filled /signed the following documents at the earliest but not later than **September 14, 2022**. Nominations received after due date without recommendation of the concerned Member will not be processed/entertained: -

✓ Surety Bond/Undertaking	✓ Proforma for Foreign Training (FTC Proforma)
✓ Five copies of Higher Education Degree.	✓ Certificate of English proficiency, Essays
