The 411th meeting of the National Highway Authority's Executive Board was held at 0900 hours on October 05, 2022 at the Auditorium of NHA Headquarters, Islamabad. Capt. (Retd.) Muhammad Khurram Agha, Chairman, NHA presided over the meeting.

Agenda Item 2

Evaluation of FWO Bid, Received under PPRA Rule 42(f) in respect of Balance & Additional Works of Rawat-Rawalpindi Project Phase-II i.e. Conversion of 2 Lane Lai and Sawan Bridges to 4 Lane Bridges at Km 1533+000 to 1534+001 on N-5

Decision

The NHA Executive Board approved the following:

- a. Award of balance & additional works of Rawat Rawalpindi Project Phase-II i.e., Conversion of 2 lane Lai and Sawan bridges to 4 lane bridges at km 1533+000 to 1534+000 on N-5 to M/s FWO at negotiated cost of Rs. 1,799,067,967/-through Direct Contracting with State Owned entities as per PPRA Rule 42-(f).
- b. The total duration of contract with M/s FWO for balance and additional works shall be only 12 months.
- c. Allocation of funds amounting to Rs. 1,353 million from AMP 2022–23 in addition to already allocated amount of Rs.447 million in AMP 2021-22.
- d. Permission be granted to P&CA to proceed the procurement with available Tender Opening & Evaluation Committees, as this work is required for the finalization of the original contract at the Risk and Cost of the Contractor.



The Board nominated Chief (NTRC) as inquiry officer to conduct fact finding inquiry to determine the reasons for failure of Lai- Sawan Bridge Project. GM (RAMD) NHA will act as Departmental Representative (DR).

The Board also directed Member (Planning) to submit the revised CSR based on current market rates for consideration within one month.

The NHA Executive Board recommended the revised PC-I for Land Acquisition of Zhob - Kuchlak Road Section of N-50, Km 0+00 to Km 298+00 (Length: 298 Km) at revised cost of Rs. 7,224.417 million (which is 123.53% above the Original Approved PC-I cost) for consideration of ECNEC. The compensation cost component of the revised PC-I is based on assessment made by the Deputy Commissioners/Collectors of concerned districts for land, trees, orchards, tube wells, ponds, water channels and structures.

Suggested Amendments in NHA Code Regarding Competent Authority for Technical Sanction

Decision

The NHA Executive Board approved following SOP for improvement in the performance during Design Phase:

- a. Monitoring of design consultant during field survey & investigation is required.
- b. Resources of Design Section is limited, therefore, either Project Director be posted at the Planning & Design Phase of the project or Zonal Member may assign appropriate General Manager (Engr) under his



domain, by giving additional responsibility to coordinate and monitor the site activities of Design Consultant.

- c. Nominated GM (Engr) will ensure that consultant has mobilized the field staff for necessary survey/investigations.
- d. After completion of design, Design Consultant will issue certificate regarding the following:
 - i. Design and specifications are in accordance with sound engineering/practices.
 - ii. The materials for the execution of the work are in strict accordance with the plans and Specifications.
 - iii. In assessment of the project cost, utmost economy has been observed consistent with good workmanship and good materials.
 - iv. The estimate represents carefully budgeted cost of execution of the work including all accessory and consequential services calculated as accurately as is possible at the time of its preparation.
- e. After in-house scrutiny under available resources in the Design Section, General Manager (Design) and nominated General Manager (Engr) shall concur the said certificate prior to submission to competent authority.
- f. After approval of competent authority, General Manager (Design) shall issue notification of the Technical Sanction for PSDP project and GM (RAMD) shall issue notification for the Technical Sanction of RMA funded/ Deposit Works.

The Board also approved the following amendments in NHA Code to harmonize it with all type of contracts/SOP:
