Administrative Approval of the Engineer's Estimate for Rehabilitation of KKH N-35 between Km 190+00 to 292+00, Thakot – Dassu on Funds Sharing Basis with WAPDA

- a. Administrative approval of the Engineer's Estimate for Up-Gradation/Rehabilitation of KKH N-35, Between KM 190+00 -292+00 (Thakot Dassu) amounting to Rs.4,332,039,936/- on mutual sharing basis by WAPDA & NHA on 75% and 25% shares respectively. NHA Shall charge its share (25%) amounting to Rs.1,083,009,984/- from Annual Maintenance Plan 2022-23 under Periodic Maintenance/Rehabilitation allocation earmarked for Northern Areas region.
- b. Approval to initiate the procurement proceeds as per Rule 42-f of PPRA i.e. Direct Contracting with state owned entities, being time sensitive scheme in larger public interest.
