Introduction

The 423rd meeting of the National Highway Authority Executive Board was held at 0900 hours on January 31 and 1000 hours on February 01, 2023 at the Auditorium of NHA Headquarters, Islamabad. Capt. (Retd.) Muhammad Khurram Agha, Chairman, NHA presided over the meeting.

- c. Allocation of funds from Road Maintenance Account (Administrative Expenses Head) of AMP 2022-23 and onwards.

The Board directed to submit detailed design and cost estimation by EPC Contractor for approval.

The Board also directed that the endorsement for construction of NHA Residential Complex in loop of motorway be treated as one time exemption not as policy.
