The NHA Executive Board approved Addendum No. 01 of M/s NESPAK for Consultancy Agreement regarding "Design & Design Review & Construction Supervision for Dualization & Improvement of Old Bannu Road Project N-55 Gandhi Chowk Sarai Naurang (8 Km) & Domail - Khurram (40 Km) Sections" amounting to Rs.117,266,068/-(Rupees one hundred seventeen million, two hundred sixty-six thousand and sixty-eight only), which is 117% above the original consultancy cost of Rs. 99,724,794/- with Extension of Time (EOT) w.e.f.
