Award of Work: Construction of 6-Lane Overhead Bridge at Imamia Colony Railway Crossing Shahdra

Decision

The NHA Executive Board approved the award of work for "Construction of 6-Lane Overhead Bridge at Imamia Colony Railway Crossing Shahdara" to the lowest evaluated bidder M/s National Logistic Cell Engineers (NLC Engineers) at evaluated bid price of Rs.3,379,452,758.00 (Rupees three billion, three hundred seventy-nine million, four hundred fifty-two thousands, seven hundred & fifty-eight only), which is 125.90% above the Engineer's Estimate of Rs.1,496,000,667.47 based on CSR-2014 and 37.48% above the Engineer's Estimate of Rs.2,458,134,714.79 based on CSR-2022 subject to approval of Revised PC-I.
