Award of Works: Engineering Procurement and Construction (EPC), China – Aid Project of Pakistan National Highway N-5 Sectional Rehabilitation

Decision

The NHA Executive Board approved the award of Works for "China – Aid Project of Pakistan Highway N-5 Sectional Rehabilitation" to the most preferred bidder M/s China Yunnan Sunny Road and Bridge Corporation Limited at their evaluated bid price of RMB 635,862,757/- (RMB six hundred thirty-five million, eight hundred sixty-two thousand, seven hundred & fifty-seven only), which is within the granted EPC construction cost.

The Board directed to complete the process for award of works within two weeks.

Ltd. (NESPAK) at negotiated/rebated cost of Rs.85,000,000/- (Rupees eighty-five million only), through PPRA Rule 42 (d) (iii) i.e., Negotiated Tendering.
