Subject: **LONG TERM PARTICIPANTS (JICA DEVELOPMENT STUDIES PROGRAM ON SDGS GLOBAL LEADER JFY 2024) TO BE ORGANIZED BY JAPAN INTERNATIONAL COOPERATION AGENCY (JICA)**

Economic Affairs Division (EAD), Islamabad has circulated the schedule of "Master Degree - 2 Years Duration and Doctoral Degree - 3 years Duration" in Japan and has invited suitable nominations of relevant Officer from NHA. *The Officers who fulfill the following eligibility criteria of Sponsor/NHA are only eligible: -*

Eligibility Criteria of (Sponsor)

a.	Young or Middle Government Official
b.	Be 35 years of age in principle (as of April 1 st 2024) for Master Degree Program
c.	Be 40 years of age in principle (as of April 1 st 2024) for Ph.D Program
d.	Have a Bachelor's Degree for Master Program and Master's Degree for Ph.D Program
e.	Proficient in Spoken and written English
f.	Applicants must not be receiving no planning to receive another scholarship during the program

NHA's Eligibility Criteria

a.	Minimum three years' service in NHA.
b.	Must be a regular employee of NHA.
c.	The employee has not attended any other program abroad for duration of more than one month during last one year.
d.	His / her job is related to the scheduled program
e.	Not dealing with any special assignment
f.	Neat and clean service record & no departmental proceedings are pending or under process against him or area of his existing responsibility
g.	The employee is not on long leave (leave of 30 days or more)
h.	He is not dealing with a special assignment
i.	He is not under medical treatment/leave for long time
j.	Recommendation by the Member In-charge

Matter is circulated for information, dissemination and seeking suitable nominations/willingness of Officers **who fulfill the above mentioned criteria of Sponsor/NHA** in said degree programs along with 05 sets of duly filled /signed the following documents at the earliest but not later than **September 18, 2023**. Nominations received after due date without recommendation of the concerned Member will not be processed/entertained: -
