AWARD OF CONTRACTS FOR THE OPERATION, MANAGEMENT AND MAINTENANCE OF BUS BAYS WITH PROVISION OF PUBLIC FACILITIES

1. National Highway Authority (NHA) **RE-Invites Bids** Regarding **Operations, Management & Maintenance Contracts (OM&MC)** for each Maintenance Unit Packages of Bus Bays on Advance Quarterly Net Guaranteed Revenue basis with 10% Annual enhancement cumulatively to the Private business entities (either sole proprietorship or partnership firm) from through open/competitive bidding initially for a Period of **Three (03) Years and After One (01) year, Further Extendable for Two (02) Years Subject to Satisfactory Performance based on One (01) year Performance**. Details of Bus Bays are provided in the Request for Proposal (RFP)/Bidding Documents.
2. Bidding will be carried out by adopting “**Single Stage Two Envelope**”. All eligible/interested bidders registered with Income Tax Department and who are on Active Taxpayers List of the Federal Board of Revenue, having valid PEC registration in Category **O-5** for the year 2024. Bid Security amount of **Rs.500,000/-** for each Location in shape of P.O./CDR in favor of “**National Highway Authority (Road Maintenance Fund-Security Deposit)**”. Details are as under: -
