# Subject: <u>The 453<sup>rd</sup> Meeting of the NHA Executive Board Held</u> on January 19, 2024 at Islamabad

#### **Introduction**

The 453<sup>rd</sup> meeting of the National Highway Authority Executive Board was held at 1000 hours on January 19, 2024 at the Auditorium of NHA Headquarters, Islamabad. Mr. Arshad Majeed Mohmand, Chairman, NHA presided over the meeting.

The meeting commenced with recitation of verses from the Holy Quran with Urdu translation and Darood Sharif.

- c. Directions will be conveyed to concerned Regional GMs to ensure maximum collection of toll during interim arrangements.
