1. National Highway Authority intends to "Open Re-Auction of Unserviceable/ Surplus Items as per following detail on "As is Where is" basis at the office of Deputy Director (Maintenance) NHA Rawalpindi, Adjacent Byco Petrol Pump near Motorway Chowk Peshawar Road (N-5), Rawalpindi".

- 2. The Open Auction will be held on **April 24, 2025 (Thursday) at 12:30 Hours** on "As is where is basis" in the presence of Representatives of Bidders at the office of Deputy Director (Maintenance) NHA, Rawalpindi.

The interested parties are required to submit Rs. 50,000/- as security deposit (Refundable) in form of Pay Order/Demand Draft of any schedule bank in favour of National Highway Authority Retention Money Account. After approval of the case from competent authority, highest bidder will deposit 25% of bid amount on the spot in form of Cash/Pay Order/Demand Draft in favour of National Highway Authority Receipt Account Punjab North Lahore and remaining 75% will be deposited within a week time. The income Tax and other local taxes shall be levied as per existing rules of the Government.
- 5. In case, the successful bidder fails to deposit the remaining 75% amount within the prescribed time, the security deposit of the same bidder shall be forfeited and NHA may re-auction trees at its will. No claim what so ever of such bidder will be accepted by NHA.
