#### Agenda Item 5

Grant of NOC to Government of Sindh for Improvement and Widening of 14 Km (From Km 33+400 to Km 47+000) of N-5/Karachi – Thatta – Hyderabad Road (KTHH) with Their Own Funds, Without De-Federalization of the Road

Relocation of Sassui Toll Plaza from Km 44+000 to a Suitable Location Between Km 120+000 to Km 125+000 on N-5/ KTHH

#### **Decision**

The NHA Executive Board approved the following:

a. Granted NOC to Government of Sindh for Widening & Improvement of 14 Km from Km 33+400 to Km 47+000 of N-5/KTHH at their own funding, without de-federalization of the road. Road will return to NHA on completion of concession period in the light of earlier decision taken in 196th Executive Board meeting.

- b. Sassui toll plaza may be re-located from Km 43+000 to Km 120-125 N-5/KTHH after June 30, 2018. Procurement of Sassui Toll Plaza for F.Y 2018-19 be initiated at new/proposed location.
- c. NOC to GoS will be effective from July 01, 2018 along with relocation of Sassui toll plaza.

Rs.98,382,326/- (Pak. Rupees Ninety Eight Million, Three Hundred Eighty Two Thousand, Three Hundred and Twenty Six Only).

The Board directed Member (Planning) to submit a separate proposal for future design reviews by the third party and direct payment of cost to the third party to maintain transparency for approval of Board.
