Grievance Report on Award of Hyderabad Sukkur Motorway on BOT Basis

Keeping in view the monetary conditions and financial constraints of Government of Pakistan, ongoing procurement process of Hyderabad Sukkur Motorway (M-6) on build-operate-transfer basis is annulled and NHA should consider an option of cross subsidization, instead of giving direct financial subsidy/Viability Gap Funding.
- b. NHA, in consultation with legal counsel, shall put up a draft annulment letter in next Board meeting.
- c. NHA should undertake Commercial Feasibility under cross subsidization mode and prepare new PC-I and then initiate procurement process, afresh, under PPP arrangement.
