#### Agenda Item 2

Approval for Award of Contract for Operation & Management of Rest Area/Resort at Km 123 Near Naran on N-15

#### **Decision**

The NHA Executive Board awarded contract for "Operation & Management of Rest Area/Resort at km 123 near Naran on N-15" to M/s CHIB Enterprises with total NHA's revenue share of Rs.56,529,942 (Rupees fifty-six million, five hundred twenty-nine thousand, nine hundred forty-two only) exclusive of all taxes for a period of ten (10) years on the recommendations of sub-committee of the Executive Board.

The Board directed that after expiry of 10 years agreement, no further extension in the agreement shall be made. A fresh bidding process will be initiated and presented before the NHEB for approval.

# Consultancy Services for GIS Survey and Development of Geo Database for Entire NHA Network

#### **Decision**

The NHA Executive Board approved award of agreement for Consultancy Services for "GIS Survey and Development of Geo Database for Entire NHA Network" to M/s Engineering General Consultants-EGC (Pvt.) Ltd. in JV with M/s Country Survey and Mapping Services (Pvt) Ltd. the highest ranked Consultants in the Combined (Technical + Financial) evaluation, at the evaluated cost of Rs.133,469,600/- (Pakistani Rupees one hundred thirty three million, four hundred sixty nine thousand and six hundred only).

The Board also approved the captioned scheme/ project as processed by the RMA Steering Committee in its meeting held on March 18, 2019 to incur the expenditure of Rs.133,469,600/- from NHA's Road Maintenance Account in respect of consultancy services for GIS Survey and Development of Geo Database for entire NHA network out of the AMPs 2015-16 to 2018-19.

The Board directed that the scope of work of each JV partner in consultancy services must be expressly defined in the agreement.

## Agenda Item 4

Consultancy Services for Improvement and Widening of Chakdara - Chitral Road Project (N-45)-Section-III Kalkatak to Chitral (48.0 Km). (Improvement in the Procurement Process and Evaluation Criteria for Consultancy Services)

# **Decision**

The NHA Executive Board approved the amendment in Agenda Item 12 titled "Improvements in the Procurement Process & Evaluation Criteria for Consultancy Services" Para 15.6 (f) of its decision accorded in its 274<sup>th</sup> meeting held on February 14, 2017 in the following manner:

"Any key position that remains vacant for more than one month that was required to be filled for that period, a compensation equivalent to the charge rate of that individual will be imposed. For clarification, the invoice will not include the charge rate of the missing individual and





additionally, the charge rate of one month for that individual will be deducted from the invoice. This will be replicated for all missing key personnel. For the 2nd month, the compensation payment will be doubled. For the 3<sup>rd</sup> month, an additional warning will be issued. If the issue persists in the fourth month, the decision for further penalty will be made by the Employer."

## Agenda Item 5

Consultancy Services for Design Review and Construction Supervision for Improvement & Widening of Chitral-Garam Chashma-Daraha Pass Road (82.50 Km)

## **Decision**

The NHA Executive Board approved the award of agreement for consultancy services for "Design Review for Construction/Improvement and Widening of Chitral-Garam Chashma-Doraha Pass Road (82.50 Km)" to M/s National Engineering Services Pakistan (Pvt) Ltd. in JV with M/s Engineering General Consultants EGC (Pvt) Ltd. and M/s PAVRON the highest ranked Consultants in the Combined (Technical + Financial) evaluation, at the evaluated/rationalized cost of Rs.170,757,975/- (Rupees one hundred seventy million, seven hundred fifty seven thousand, nine hundred and seventy five only).

The Board directed that the scope of work of each JV partner in consultancy services must be expressly defined in the agreement.

Since signing of the agreement, till start of Construction Supervision, no escalation in salary cost shall be claimed by the Consultants.

#### **Decision**

The NHA Executive Board instructed to resubmit the PC-I for "Sustainable National Highway Rehabilitation & Improvement Project (SNHRIP)" amounting to Rs.42,492 Million after short-term implementation plan of Axle Load Control Regime is enforced.





The Board directed that political backup must be ensured for successful implementation of the SNHRIP project. For implementation of axle load by NH&MP, there should be sufficient provision of funds in the project for field staff of NH&MP and allied facilities i.e. residences, vehicles, POL, etc.
