Approval for Award of "Rehabilitation of N-25 from KM 24 to KM 27 (Hub City Portion)" of Balochistan South Region under AMP 2017-18

Decision

The NHA Executive Board approved the award of Work for "Rehabilitation of N-25 from KM: 24 to KM: 27 (Hub City Portion)" to the Lowest Evaluated Bidder M/s Zarak Construction Company at evaluated bid price of Rs.105,800,425/- (Rupees one hundred five million, eight hundred thousand, four hundred & twenty five only), which is 34.00% below the Engineer's Estimate with 10% additional Performance Security in addition to Performance Security (10%) already stipulated in Appendix-A to Bid.
