#### CONFIRMED MINUTES

Subject: The 329th Meeting of the NHA Executive Board

Held on November 21, 2019 at Islamabad

### Introduction

The 329<sup>th</sup> meeting of the National Highway Authority's Executive Board was held at 1100 hours on November 21, 2019 at the Auditorium of NHA Headquarters, Islamabad. Capt. (Retd.) Sikander Qayyum, Chairman, NHA presided over the meeting.

The meeting commenced with recitation of verses from the Holy Ouran.

# **Opening Remarks**

The Chairman extended warm welcome to all participants of Board meeting.

The Sr. JS (MoC) brought attention of the Board Members towards the instructions of Federal Government regarding fixation of annual remunerations for individual members of Boards. He requested to let it inform the actual limits in this regard.

The Chairman directed Member (Finance) to examine the Federal Government instructions regarding remunerations fixed for attending the Board meetings. The Board further directed to check if there is any annual upper cap limit fixed for the individual members and to apprise the Board accordingly.

The Chairman allowed Secretary NHA to start formal Board proceedings on the agenda.

# Formal Board Proceedings

## Agenda Items

The Secretary NHA apprised the Board that 10 (ten) working papers were circulated.



PC-I for Construction of Dera Murad Jamali Bypass on National Highway N-65

### **Decision**

The NHA Executive Board recommended the PC-I for construction of Dera Murad Jamali Bypass on N-65 at a cost of Rs.1.860 Billion having an Internal Rate of Return (IRR) of 12.52% for approval by DDWP.

## Agenda Item 2

PC-I for Construction of five (05 Nos) Road user facilitation centers on Zhob-Mughal Kot Section of N-50 & Qila Saifullah - Loralai - Waigum Rud Section of N-70

## **Decision**

The NHA Executive Board recommended the PC-I of "Construction of 5 No. Road User Facilitation Centers on Zhob - Mughal Kot Section of National Highway N-50 & Qila Saifullah - Loralai - Waigum Rud Section of National Highway N-70" amounting to Rs.450.534 million to DDWP for approval.

The Board further directed that local architecture be adopted while construction of buildings besides provision of solar lights and solution to water issue at sites.

# Updated PC-I for Construction of Malakand Tunnel Project

#### **Decision**

The NHA Executive Board recommended the 2<sup>nd</sup> Revised PC-I for Design, Tendering Assistance and Construction of Malakand Tunnel Project at a cost of Rs.23.565 Billion having an Economic Internal Rate of Return (EIRR) of 8.25% for approval of ECNEC.

The Board directed to perform 3<sup>rd</sup> party review/validation of 2<sup>nd</sup> revised PC-I for design, tendering assistance and construction of Malakand Tunnel Project.

#### Agenda Item 4

Updated PC-I for Construction of 2-Lane Bridge Over River Indus at Ghazi Ghat

## **Decision**

The NHA Executive Board recommended the updated PC-I for Construction of 2-lane Bridge over River Indus at Ghazi Ghat Project at a cost of Rs.1.987 Billion having an Economic Internal Rate of Return (EIRR) of 14.11% for approval of DDWP subject to third party review/ validation of the PC-I.

The Board directed that the breach sections be provided in approach roads along with capillary breaking layer in view of site situation. The Board further directed that the scoured depth and geological survey of the project be performed before execution.

Concept Paper for Construction of Tunnel (03 KM) with Link Access Road (05 KM) Electrical & Mechanical Work at Lohargali-Bararkot Azad Jammu & Kashmir (AJK)

## **Decision**

The NHA Executive Board recommended the concept paper for "Construction of (3-km) Tunnel with link access road (5-km) and Electrical & Mechanical work at Lohargali - Bararkot Azad Jammu & Kashmir" Project at a cost Rs.9.719 Billion for approval of CDWP.

### Federalization of Roads in District Chitral

### **Decision**

The NHA Executive Board recommended the federalization and improvement and widening of Chitral-Boon-Mastuj-Shandur-Gilgit Road (363 KM) for approval by the National Highway Council. The Board also directed to revise the PC-I to bifurcate the project into packages.

The Board deferred the case for federalization of Chitral-Ayun-Bumborate Road (48 KM) and Chitral-Garam-Chashma-Doraha Pass Road (82.5 KM).
