Subject: The 330th Meeting of the NHA Executive Board Held

on December 13, 2019 at Islamabad

#### Introduction

The 330<sup>th</sup> meeting of the National Highway Authority's Executive Board was held at 1000 hours on December 13, 2019 at the Auditorium of NHA Headquarters, Islamabad. Capt. (Retd.) Sikander Qayyum, Chairman, NHA presided over the meeting.

The meeting commenced with recitation of verses from the Holy Quran.

# Opening Remarks

The Chairman extended warm welcome to all participants of Board meeting.

The Sr. JS (MoC) raised the issue regarding implementation of time scale promotion policy for NHA employees that was approved by the National Highway Council (NHC) in the year 2017 and now ratified by the Federal Cabinet. He showed concern over delay in implementation of the policy. He pointed out that few employees have retired and some are near to superannuation, therefore, he requested the Chairman for early implementation of the policy, which will surely increase motivational level of employees, who are stuck up in same scales for years.

The Chairman appreciated the concern of Sr. JS (MoC) for highlighting this important issue. He assured that he will examine delay in the matter and will implement the same as early as possible.

The Chairman allowed Secretary NHA to start formal Board proceedings on the agenda.

Addendum No. O1 of the Joint Venture of M/s Asif Ali Associates (A.A.A) (Pvt.) Ltd (Lead Firm), M/s Associated Consultancy Centre (ACC) (Pvt.) Ltd and TurkPak International (Pvt.) Ltd: Consultancy Contract for Detailed Design and Construction Supervision of Improvement/Widening of Thokar Niaz Baig – Hudiyara Drain Section of N-5

#### **Decision**

The NHA Executive Board approved Addendum No. 01 of the Consultant (M/s Asif Ali & Associates in JV with Associated Consultancy Centre & TurkPak International) for Detailed Design and Construction Supervision of Improvement/Widening of Thokar Niaz Baig to Hudiyara Drain Section of Multan Road N-5 costing Rs.29,080,283/- with revised consultancy cost of Rs.74,678,122/- (an overall increase of 63.78%) along with EOT of 314 days i.e. up to September 30, 2019 (in line with EOT accorded to the Contractor).

The Board directed that in future, EOT cases of Contractors and Consultants be simultaneously processed.

The Board further directed that PC-I of the project be revised and got approved from competent forum on account of revision in original scope of work.
