Sub: The 333rd Meeting of the NHA Executive Board Held on February 12, 2020 at Islamabad

Introduction

The 333rd meeting of the National Highway Authority's Executive Board was held at 1030 hours on February 12, 2020 at the Auditorium of NHA Headquarters, Islamabad. Capt. (Retd.) Sikander Qayyum, Chairman, NHA presided over the meeting.

Inclusion of Completed/Substantially Completed Projects in PSDP 2019-20

Decision

The NHA Executive Board approved, in principle, inclusion and provision of funds under head of "Completed/ Substantially Completed Projects" in PSDP 2019-20 with total allocation of Rs.12.665 Billion and minimum allocation of Rs.6 Billion in 3rd Quarter of PSDP 2019-20."

The Board directed that a final list of year wise completed/substantially completed projects be presented before the Board in next meeting along with complete expenditure details and PC-Is' status.

The Board further directed that land acquisition liabilities statement be presented before the Board for review.

Agenda Item 3

Construction of Hyderabad - Sukkur Motorway Project (306 KM) on BOT Basis under PPP Arrangement

Decision

The NHA Executive Board approved the following:

- a. Implementation of Hyderabad-Sukkur Motorway (M-6) on PPP mode (Option 3A: BOT-Cross Subsidy+NHA Revenue share) by Cross-Subsidizing the net toll revenue only of Sukkur-Multan Motorway (M-5) upto the end of debt servicing period.
- b. The Concessionaire will be responsible for operation and maintenance of Motorway M-5 during that period except the service areas and commercialization of ROW revenue which will remain under the control of NHA.

PC-I for Construction of New Bridge on River Chenab between District Multan & District Muzaffargarh (Shujabad – Khangarh)

Decision

The NHA Executive Board recommended the PC-I for Construction of new bridge on River Chenab between Shujaabad and Khangarh Project at a cost of Rs.9.56 Billion as deposit work of Government of the Punjab having an EIRR of 17.35% for approval of CDWP.
