Subject: <u>The 338th Meeting of the NHA Executive Board Held</u> on May 05, 2020 at Islamabad

Agenda Item 1

Confirmation of Minutes: 337th Meeting of Executive Board held on April 08, 2020

Decision

The NHA Executive Board confirmed minutes of the 337th Executive Board meeting held on April 08, 2020 with some amendments.

<u>Agenda Item 2</u> PC-I for Construction of 4-Lane Flyover at Bhara Kahu (N-75)

Decision

After detailed deliberation as above, the NHA Executive Board recommended the "PC-I for Construction of 4-Lane Flyover at Bhara Kahu (N-75) project at a cost of Rs.7.608 Billion for approval of CDWP and instructed that:

- a. Traffic projections of through traffic should be included separately in PC-I and accordingly economic analysis be revised.
- b. CDA's NOC in writing be obtained before proceeding to improve CDA's road for utilization as diversion.
- c. Cost for improvement of CDA's road to be used as diversion should be separately mentioned in the PC-I.
- d. Traffic modeling of existing Bhara Kahu interchange also be carried out.

Agenda Item 3

PC-I for Construction of Hoshab - Awaran - Khuzdar Section of M-8 Project - Package-01: Hoshab - Awaran Length 146 KM (02 Lane Construction)

Decision

After detailed deliberation as above, the NHA Executive Board recommended the "PC-I of Construction of Hoshab – Awaran ~ Khuzdar section of M-8 project (Package -01: Hoshab ~ Awaran, length: 146 km (02 lane construction) project at a cost of Rs. 26,661 million for approval of ECNEC with following conditions:

- a. Cost of toll plaza & allied works and weigh stations be excluded from the cost of PC-I.
- b. Economic analysis be recalculated and adjusted accordingly.



c. The project will be executed under the government grant and not on CDL.

The Board directed that NHA should also submit alternate proposal along with the PC-I for consideration of CDWP.

Agenda Item 4

PC-I for Construction of Dalbandin - Ziarat - Balanosh (77 KM) District Chaghi

Decision

After deliberation as above, the NHA Executive Board recommended the "PC-I for Construction of Dalbandin-Ziarat Balanosh (77 km) District Chaghi" project at a cost of Rs. 9,644.4 million for approval of CDWP subject to review of traffic study by Chief (NTRC) in light of the Board's observations.

The Board directed that NHA should also submit alternate proposal along with the PC-I for consideration of CDWP.

The Board also authorized the Chairman, NHA to constitute a three members technical committee to supervise and monitor performance of the development process and present progress report before the Board after every three months.
