Confirmation of Minutes: 338th Meeting of Executive Board held on May 05, 2020

Decision

The NHA Executive Board confirmed minutes of the 338th Executive Board meeting held on May 05, 2020 with following amendments:

Annual Maintenance Plan for F.Y. 2019-2020

Decision

The NHA Executive Board approved Annual Maintenance Plan F.Y 2019-20 amounting to Rs. 34,493.74 million in addition to previous year's AMPs throw forward amounting to Rs. 20,223.66 million with following conditions:

- a. Preventive maintenance head be merged with special maintenance head.
- b. The allocation for land acquisition in Corridor Management head be merged with Geometric improvement head.
- c. Allocation of Rs. 600 million for bridge/culvert structural maintenance be revised to Rupees one billion by reducing Rs.400 million from the special maintenance head.

The Board directed that details of allocation for special maintenance and proper procedure regarding award of works be presented in the next Board meeting.

The Board constituted following committee to review existing system & preparation of AMP and submit its recommendations for improvement:

- a. Member (Planning)
- b. Member (Finance)
- c. Chief (NTRC)
- d. Member (Engg. Coord)

The ToRs of the committee are as under:

a. To examine the current annual based planning process and option of implementing three years execution rolling plan.



- b. To suggest merits/demerits of planning maintenance cycle according to calendar or financial year basis.
- c. To suggest proposed amendments in relevant rules in this regard.
- d. To make recommendations for revamping of RAMD in order to streamline the maintenance works.
- e. To make recommendations for preventive maintenance of roads as per international best practices.

The NHA Executive Board approved the award of "widening of Tata - Pani Slide Area at KM: 467+000 on N-35 pertaining to Giglit Baltistan Region under Annual Maintenance Plan (AMP-2017-18)" to lowest evaluated bidder M/s MT Khan (two bidders were qualified) at Evaluated Bid Price of Rs.76,214,179.90 which is 15.00% below than Engineer's Estimate amounting to Rs.89,663,741.06 based on CSR-2014 as per NHA Code: 2005, Chapter-03, Para-10(c) (revised in 2010).
