The 340th Meeting of the NHA Executive Board Held on July 08, 2020 at Islamabad

Introduction

The 340th meeting of the National Highway Authority's Executive Board was held at 1130 hours on July 08, 2020 at the Auditorium of NHA Headquarters, Islamabad. Capt. (Retd.) Sikander Qayyum, Chairman, NHA presided over the meeting.

The meeting commenced with recitation of verses from the Holy Ouran.

Opening Remarks

Report of Committee Constituted by Executive Board in its 339th Meeting held on May 20, 2020 on "Amicable Settlement of Dispute Regarding China-Pakistan Economic Corridor (CPEC), Western Route, Construction of Hakla (M-1) to D.I Khan Motorway (Package-IV), Pindigheb to Tarap (KM 0+000 to KM 50+019)"

Decision

NHA Executive Board advised that the Chairman, NHA may proceed with the recommendations of Stage-II Committee for Amicable Settlement of Dispute, endorsed by the Committee constituted by Executive Board, which are listed below:

- a. Ratio of item 108a and 108b in the Embankment material will be 60% & 40%, respectively.
- b. As per this Amicable Settlement, the rate of item 108b would be Rs.575/CM without any rebate or escalation. (Applicable in quantities over & above the original BOQ quantities).
- c. The Contractor shall withdraw all his Claims to-date pertaining to this project including but not limited to Idling Claims, Prolongation Cost Claims etc.
- d. No interest on delayed payment, if any, will be admissible on any delayed payment to-date, relating to this project.
- e. The matter of Extension of time in the Contract shall be decided through an Amendment in the Contract.

The Executive Board also advised the Chairman, NHA to approve conversion of the Performance Security in shape of Bank Guarantee to Insurance Guarantee/Bond for the extended period, on Package-IV, as part of amicable settlement in the best interest of the Project.

Approval for Award of Periodic Maintenance Work Rehabilitation between KM: 115+000 to KM: 119+500 on N-65 (Dera Murad Jamali Urban Area) pertaining to Balochistan North Region under AMP-2018-19

Decision

The NHA Executive Board approved award of Periodic Maintenance Work (Rehabilitation) between Km 115+000 to Km 119+500 on N-65 pertaining to Balochistan North Region under AMP 2018-19 to the lowest evaluated bidder, M/s Karamullah Construction Company at evaluated bid price of Rs.167,738,103/-(Rupees one hundred sixty seven million, seven hundred thirty eight thousand, one hundred and three only), which is 27.80% below the Engineer's Estimate.

The lowest evaluated bidder shall provide/furnish 10% additional Performance Security in addition to Performance Security (10%) stipulated in "Appendix-A" to Bid as per Clause IB-28.4.

6.19. The Board directed the Member (Engg. Coord) to analyze and submit before and after completion status of the maintenance projects executed during last three year.
