Award of Works for Construction of Additional 02-Lane Carriageway from Ratodero to Shikarpur N-55 (Section-1) KM 0+000-Km 43+400 (43.4 Km)

Decision

The NHA Executive Board approved award of works for "Construction of Additional 2 Lane Carriageway from Ratodero to Shikarpur N-55 (Section-1) Km 0+000-Km 43+400 (43.4 Km)" to M/s Top International Engineering Corporation - Umer Jan & Co (TIEC-Umer Jan) Joint Venture at the Lowest Evaluated Bid Price of Rs.4,942,662,910/- (Rupees four billion, nine hundred forty-two million, six hundred sixty-two thousand, nine hundred & ten only), which is 17.90% below Engineer's Estimate based on CSR-2014.

The Board also directed that relevant clause of NHA Act/ NHA Code empowering the Board should be mentioned in each proposal/decision for future proposals requiring approval of NHA Executive Board.

(Republic of Korea) in JV with M/s Dohwa Engineering Co. Ltd. (Republic of Korea) and M/s Kyoung-Ho Engineering & Architect Co. (Republic of Korea) and M/s Zeeruk International (Pvt.) Ltd. (Subconsultant; Pakistan)the highest ranked Consultants in the Combined (Technical + Financial) evaluation, at the evaluated/agreed consultancy cost of USD.4,723,590/- (United States Dollar four million, seven hundred twenty three thousand, five hundred and ninety only).
